- \*In and out privileges will be available during published times of 9:00am - 10:30pm. Lot will be locked and inaccessible after published times.
- \*Vouchers must be displayed on the window at all times. Parking vouchers are non-transferable.

- \*Transportation to America's Center is not provided. Taxi, Metrolink or Uber/Lyft are recommended options.
